## EDHEC BUSINESS SCHOOL TRANSCRIPT GUIDE GRADUATE DIVISION

## **PROGRAMME**

The graduate division of EDHEC Business School (<a href="http://www.edhec.edu">http://www.edhec.edu</a>) features a range of business management and financial economics specializations. Courses and credits are organized within an ECTS framework, typically 60 ECTS per year for full time study. Courses in the Master Degree track are designed to train students in disciplinary or industry specific areas where problem-solving, critical thinking and good depth and breadth of general knowledge are essential. International students are admitted into the Business Management or Financial Economics programmes based on institutional partnerships allowing students to transfer credit per semester or per year. Selected candidates may be eligible for the double degree.

## **ECTS INFORMATION**

The academic year is divided into two semesters running from late August through June for full time programmes. Each semester corresponds to 30 ECTS with a full year at 60 ECTS or the equivalent of 1500-1800 working hours depending on level, type of course and major concentration. Generally, a 30-hour course earns 4 or 5 credits (with 1 ECTS approximately equivalent to 25-30 working hours). A French and an ECTS grading scale are included on transcripts. French grades follow a 0-20 grading system with a minimum credit grade of 10. Class course averages tend to cluster at 13-14, with occasional slight variations in grade distributions across disciplines, levels and types of course. The grades of 18, 19 and 20 are rare.
